**Background Information:**

On September 7, 2021, City Council conditionally approved an Out of City Utility Connection request for water and wastewater service subject to the property being annexed and zoned.

The applicant is requesting annexation and zoning for a convenience store with fuel sales to be developed pursuant to the regulations of the Heavy Commercial (HC) zoning district. The annexation will also include the adjacent Hwy 123 and Clovis Barker Rd.

Water service will be provided by the City of San Marcos. The Property is not covered by a wastewater CCN; however, the City of San Marcos has wastewater lines adjacent to the Property and will make wastewater service available to the Property. Bluebonnet Electric COOP will provide electric service for this development. The City of San Marcos will provide Police, Fire, and EMS services.
