### Background Information:

This is a workshop to update City Council on the Fiscal Year 2023 budget process and condition.

In this workshop, City Council will receive information on preliminary revenue projections, cost drivers, and preliminary estimates of budget capacity available for department's supplemental requests.

Next steps: We will continue to refine revenue projections as additional economic information is received. Taxable assessed values will be certified by the Appraisal District on July 25<sup>th</sup>. The Hays County Tax Assessor / Collector will make the required tax rate calculations for the City. This normally occurs within 2 weeks of certification. These calculated rates determine the range of tax revenue available to the City without requiring an election. The budget policy approved by City Council allows for a tax rate at or below the current tax rate. The next budget workshop is scheduled August 18<sup>th</sup> for in depth discussion on the Proposed budget and the proposed tax rate. In addition, at that time, City Council will set the dates of public hearings to allow for public input on the City's budget and tax rate which is anticipated to be adopted on second reading on September 20<sup>th</sup>.
