Background Information:

In 2017, the City of San Marcos entered into an interlocal agreement with the City of New Braunfels, City of Kyle, and Texas State University to meet the agencies' Municipal Separate Storm Sewer System (MS4) state mandates, promote stormwater awareness and host an annual stormwater conference. The agreement also enumerates funding responsibility among the parties. In 2021, the City of Kyle elected to remove itself from the interlocal agreement due to staffing shortages. This update to the interlocal agreement expands the use of conference generated funds to public education and outreach opportunities and removes the City of Kyle from the agreement.
