Proper erosion control materials are needed for all construction, ground disturbing activities, or illicit discharges to prevent discharges into the storm sewer system and prevent water pollution or wildlife habitat loss in the City's rivers, creeks, and waterways. This contract will allow the Stormwater Division of the Public Works Department to purchase erosion control materials including curb inlet protection, soil retention blankets, and gabion baskets.
