Background Information:
The purpose of this project (222-210) is to address outstanding construction and maintenance needs in locations of the Police Department facility that were not included in the overall renovation contract and after
asbestos was discovered in the building. This project scope consists of installing new flooring after asbestos flooring is removed, repairing and patching sheetrock and painting walls, replacing molding and damaged ceiling tiles, and repairing two public restrooms.
Pursuant to Local Government Code 271.102 which authorizes the City to participate in cooperative purchasing programs, staff recommends award of this work to Azteca Designs, Inc., Somerset, TX, in the amount of \$186,732.82 through the BuyBoard contracts #657-21 & #642-21.
