Background Information: On May 4, 2023, the City received one (1) proposal in response to PEP #223, 032 for CDRC Estimator.
On May 4, 2023, the City received one (1) proposal in response to RFP #223-032 for CDBG Estimator Services. The single proposal received was submitted by DSW Homes, LLC, located in Friendswood, Texas.
Per federal requirements of 2 CFR 200.319(b) which govern CDBG procurements and contracts, "In order to ensure objective contractor performance and eliminate unfair competitive advantage, contractors that develop or draft specifications, requirements, statements of work, or invitations for bids or requests for proposals must be excluded from competing for such procurements." DSW Homes, LLC, is currently the City's contractor for CDBG Housing Rehabilitation Services and for CDBG Housing Construction Services; therefore, selection of DSW Homes, LLC, would be a direct violation of this federal requirement.
As a result, we have no option but to reject the proposal submitted in response to RFP #223-032 for CDBG Estimator Services.
