Background Information:

The site is located within the boundaries of the SMART Terminal (now Axis) Development Agreement which was approved in 2018 and amended in 2023 (Resolution 2023-20R). This development agreement contemplates annexation of the property and at this time the applicant is requesting annexation of a portion of a future roadway.

The subject property is part of a plat for a future roadway which will connect FM 1984 and FM 110. More than half of this proposed roadway is located within City limits and annexation will allow the construction of a single cross section based on City of San Marcos standards. The road is shown on the City's Thoroughfare Plan in the Transportation Master Plan.
