Background Information:

According to Texas Election Code Section 3.005 (c)(2), the last day to call the General Election of the City of San Marcos is August 19, 2024. Due to the time sensitive nature of this Ordinance, it is being proposed as an Emergency and will have only one reading. The Countywide Early Voting and Election Day polling places will be set by the Hays County Commissioners Court on August 6, 2024. A separate ordinance setting out the polling places for the Election will be presented for Council approval on August 20, 2024

The reason for the runoff canvass set for December 26th is that the deadline for the City Council to canvass the results of the December 2024 runoff election is the 11th day after election day.; moves to next business day, December 26.

But the actual canvass date could be earlier, pending obtaining the election returns from the election's administrator.
